Regular Meeting – November 7, 2023

- CALL TO ORDER: The Regular Meeting of the Weaverville Fire Protection District was called to order by Commissioner Todd Watkins at 1001 hours. Commissioners present: Larry Helsley and George Owen.  - i. Completed a commercial sprinkler inspection at Crumbles Bakery,
 - ii. Completed an occupancies review at Amei's Hmong Kitchen,
 - iii. That WFD hosted a Driver/operator 1A class and a 1B class is scheduled for March,
 - iv. Participated in an active shooter training at both the High and Elementary Schools,
 - v. Put tires on the back of 2151
 - vi. Completed a life safety inspection at Chappell's thrift store,
 - vii. Met with Senator McGuire who has pledged \$1.5 million in funding for the Trinity Co. Fire Chief's. It will be decided at the next meeting how the money will be spent.
 - viii. Helsley asked about the recent Mill Fire and Boorman stated that it was a compressor fire. There was extension to surrounding byproduct but that sprinklers extinguished most of it. The Mill is wanting an investigator to look at it more closely.

 - i. The Harvest Festival at Highland Art Center,
 - ii. We gave a fire prevention presentation at WES Pre-K and Kindergarten
 - iii. Multiple football standbys including peewee and homecoming parade.
 - iv. We did the First Annual Historic Fire Hall Candy Giveaway on Halloween. There was a very positive public response. Many people commented on how nice it was to see the Historic Fire Hall open.
